## ARTICLE I NAME

## ARTICLE III PURPOSE

The corporation shall be operated exclusively as a social and recreation club within the meaning of § 501 (c) (7) of the Internal Revenue Code of 1986, as now in effect or as may hereafter be amended (the "Code"). Such purposes include but are not limited to: 1. To provide an environment and forum for developing friendships and recreational opportunities, through a common interest in the fishing sport. 2. To develop, promote and disseminate fishing sports knowledge and practices. 3. To promote and disseminated information about health, safety, environmental regulatory requirements and concerns related to the fishing sport.

## ARTICLE IV MANNER OF ELECTION

Directors of the Corporation shall be elected as set forth in the Corporation's Bylaws and shall serve until their successors are elected. The number of directors may be changed by a bylaw duly adopted by those members entitled to vote; provided, however, that in no event shall the number of directors be changed to a number fewer than three (3).

In the event of dissolution or final liquidation of the Corporation, all of the remaining assets and property of the Corporation shall, after paying or making provision for the payment of all of the liabilities and obligations of the Corporation and for necessary expenses thereof, be distributed to such organization or organizations organized and operated exclusively as social and recreation clubs or for charitable or educational purposes as shall at the time qualify as an exempt organization or organizations under § 501(c)(7) or § 501(c)(3) of the Code as the Board of Directors shall determine. In no event shall any of such assets or property be distributed to any member, director or officer, or any private individual.

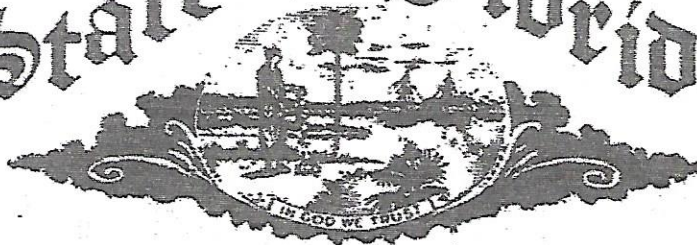
